IF YOU ARE A UK NATIONAL LIVING IN SPAIN

If you are a UK national living in Spain, you must ensure you are correctly registered as a resident, now that the UK has left the EU. Through the UK Nationals Support Fund, set up by the Foreign, Commonwealth and Development Office, IOM provides support to UK nationals to help with their residency applications, through a phone helpline, email or face-to-face case support.

All our services are free of charge. IOM's full support is available in Madrid, Andalusia and Murcia where our legal advisors are based. However, UK nationals living in other parts of Spain (Castilla La Mancha, Castilla-León and Extremadura), and who are struggling with their residency applications, are eligible to receive support through email and telephone contact.

WHAT ARE THE MINIMUM ECONOMIC RESOURCES FOR RESIDENCY APPLICATIONS IN 2020?

To successfully obtain Spanish residency, if you are not working you will be asked to provide provision of sufficient resources, for yourself and for members of your family, to demonstrate you will not become a burden on the state during your period of residence

How much money do I need to register in Spain?

Proof of sufficient resources is determined on a case-by-case basis. While there is no fixed amount that you must have, in general you should be able to show that your income is above the level at which you would become eligible for a non-contributory benefit. These levels are as follows:

How can I show these resources?

Employed in Spain

You can use your working status and contract to show income.

Self-employed in Spain

You can use your working status and will probably be asked to show the last three months taxes.

Pensioners

You will be asked to present a certificate or proof of your pension.

Persons who do not work in Spain

You will be asked to show proof of availability of financial means for the period requested. It can be shown by any means of proof, including the contribution of property titles, certified checks or credit cards accompanied by a bank certification that proves the amount available as credit on the card.

Resources such as property, bonds, savings, share certificates can also to be considered.

Students

You will be asked to provide an affidavit or responsible declaration that you have sufficient resources for you and your family members, so as not to become a burden on the state during your period of residence.
